ENTRY FEES:

1 entry: \$20 Member/\$30 Non-Member

2 entries: \$30 Member/\$45 Non-Member

3 entries: \$40 Member/\$55 Non-Member

Your payment amount will be determined by your membership status and number of entries submitted. Select a payment option. If you choose to pay online, you will be able to enter your credit card information through PayPal. If you do not pay online, you must pay by check, cash, or by calling WBCA with your credit card information. To pay by credit card over the phone, call **651.407.0597**. All entries must be submitted through the online form by Friday, January 15, 11:59 PM - **NO LATE ENTRIES WILL BE ACCEPTED**.

If you submitted your entry but did not pay your fee via PayPal, payment must be received by WBCA no later than January 22, 4:00 PM. Your entry is not official until we receive your payment.

Images must be .jpg, .jpeg, or .png. Maximum image size is 12 MB. High quality images are strongly encouraged.

ELIGIBILITY:

This online exhibition will be open to anywhere in the world where it is not prohibited by law. WBCA must be able to receive entry fees. This exhibition is open to all mediums: recent 2D and 3D works, including but not limited to drawings, paintings, fiber, pottery, photography, and sculptures. 3D works (including fiber pieces) have the option of sending 2 images of the same piece.

All entries must be submitted online for judging. All entries must be original compositions and cannot be based on anything that has been published elsewhere. Copies of other artists' work are not eligible. All entries must be 100% original and cannot have been partially completed by an instructor. WBCA reserves the right to refuse any artwork for any reason.

SELECTION:

Submission does not guarantee selection. Pieces will be selected in a jurying process facilitated by 3 judges. WBCA requests that artists write a short artist statement. WBCA reserves the right to use selected images for promotion including website and social media platforms.

SALES:

Artists can choose to sell their work directly to buyers by submitting artist contact information. WBCA can post this information online with the artist statement or send you the buyer's contact information. WBCA will not handle sales transactions or shipping and handling. **There is a suggested 15% commission from sales that should be reflected in pricing.**
